The bids shall only be opened online on GeM. No manual bids will be accepted. All quotation should be submitted on the E-procurement portal.



SUBJECT: Supply and Installation of Roller Blinds at Institute's Library building and Banquet Hall

Online Quotations are invited for the work as mentioned above and scope of work and terms & Conditions of the order shall be as follows: -

- 1. **Time Schedule:** The work shall be completed within 30 days from the date of award. In case of delay on account of reasons attributable to the Contractor Liquidated Damages shall be levied .The amount of Liquidated Damages payable by the Contractor to the institute would be 0.25% of the value of order for each calendar day of delay subject to a maximum of 5% of the value of order. Director General, MP-IDSA, decision in this regard shall be final and binding.
- 2. **Execution of Work:** The work shall be executed in best workman like manner, to the entire satisfaction of the Institute.
- 3. **Unit Price**: Unit rates quoted for the work shall be deemed to include for all material, labour, tools and accessories, as required for proper execution of work complete in all respects. Any missing minor details which are not spelt out in the description of items but are required for proper completion of work shall be deemed to have been taken into account in the quoted rates. The rates shall also include for transportation including ate of completion. The contractor shall re-do the work including replacement of items, wherein defects have developed during this period under the direction of the Estate cell, at no extra cost.
- 6. **Delivery of Materials/Items and Completion:** Inspection of the finished work will be carried out by the representative of MP-IDSA. The work shall be completed to the entire satisfaction of the Institute. On completion of the work, the contractor shall inform the Estate cell in writing with the date of physical completion of work for final approval for issue of completion certificate. Before start the work, the bidder shall forward 2-3 samples for approval of shade, color and quality of fabric. Bidder has to ensure sufficient stock of approved sample. No deviation shall be accepted once the sample is approved.
- 7. **Submission of quotation:** Appendix 'A' to the tender duly quoted and signed on all pages along with this letter in token of the acceptance of terms and conditions mentioned herein-before, should be uploaded on GeM by 1500 hrs on **30**th **Aug 2024.**
- 8. Upon acceptance of the quote, no subletting/transfer would be allowed by the Contractor.
- 9. **Earnest Money Deposit**: Bidders shall deposit Earnest Money Deposit (EMD) along with their bids. While submitting the bid, the vendor shall deposit Earnest Money of **Rs. 12000/-** by demand draft "**MP-IDSA**" payable at **New Delhi.** No other mode of remittance shall be accepted. EMD is to remain valid for a period of 90 days beyond the final bid is accepted. EMD of the unsuccessful bidders will be returned to them at the earliest latest on or before the 30th day after the award of the work. The EMD of the

successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be deposited by those Bidders who are registered MSME, etc. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender. The bidders found without EMD are liable for outright rejection.

- 10. Defect Liability: The materials & work of the contractor shall be under 2 (Two) years Defect Liability Period (DLP). Defect/s noticed during the defect liability period shall be rectified by the contractor without any cost to MP-IDSA, failing which the Security Deposit of the Contractor shall be forfeited. The contractor may also be debarred from any future tendering in the Institute. The contractor shall re-do the work, wherein defects have developed during this period under the direction of the Estate cell, at no extra cost.
- 11. <u>Security Deposit</u>: On receipt of the Letter of intent (LOI), the successful bidder shall furnish 5% of the contract value as security deposit in the form of Fixed Deposit Receipt from Nationalized Bank or Bank guarantee from Nationalised Bank. The Security deposit shall be valid for a period of 60 days beyond the defect liability period (24 Months).
- 12. **Payment Terms**: 100% payment shall be made by the Institute against satisfactory completion of work. Bidders will be fully responsible for proper installation and making the roller blind functional before the final settlement of account. All statutory deductions like TDS, GST as applicable rules shall be made from the due payment of the bidder.
- 13. Scope of work Providing and Fixing of Roller blinds make of Vista / Mac-Decor / Hunter Douglas/Nova or equivalents. Roller Blinds of superior quality and of leading manufactures, with approved colour, shade and fabrics including the cost of necessary powder coated aluminium channels, rollers and other accessories complete all as per manufacture's specifications and as per the directions of MP-IDSA. The total area for roller blinds is 200 Sqm for 42 Nos of roller blinds for different size of windows (Approx. size is 6x8 feet ,+- 3 inches variation). Details of specification is tabulated below:-

- Note:- (i) Any minor work like applying cement based putty observe during installation required to be completed without any extra cost.
 - (ii) Cleaning of stain marks before start fresh work.
 - (iii) All fitting must be covered while performing work.
 - (iv) The contractor has to make arrangements for cleaning the work site every day and on completion of the work from the work area at his cost.
 - (v) The contractor shall be paid on the basis of the actual quantity of completed work as per the scope of work. Measurements shall be taken as the frontal area of the blinds for the purpose of payment.
 - (vi) Materials bearing ISI certification mark certification shall be given highest preference for use in the works. Where the Contractor is required to do, perform, execute (etc.) any work or service or the like, it shall be deemed to be at his own cost.
 - (vii) The rates accepted in the Schedule of Quantities apply to all floors, heights, depths, leads, lifts, spans, sizes, shapes, locations, etc. unless a distinction has been included in the very Schedule.
 - (viii) Screws, bolts, nuts, washers, hold fasts, lugs, anchors, clamps, plugs, suspenders, brackets, straps and fasteners of the like are deemed to be included in the rates.
 - (ix) Resetting any displacements, making good holes/chases and such other incidental jobs are included in rates of respective items for which these are required at his own cost.

14. Warranty / Guarantee:

- (a) For the equipment The Tenderers must quote for 02 years comprehensive on-site warranty (Including all Spares, Accessories and Labour) from the date of completion of the satisfactory installation. The warranty charges shall not be quoted separately otherwise the offer shall be summarily rejected. Failure to comply this condition will entail the rejection of the bids.
- (b) No offer of the vendor will be accepted without warranty/ guarantee of their supplied/ installed goods.

15. Eligibility:

- (i) Bidder should have satisfactorily completed **one similar work** in Central Autonomous Body/Central PSU/ Central Undertaking Body//Educational Institute).
- (ii) Firm should produce completion certificate of such works from organization /Autonomous body.
- (iii) Firm should have PAN & GST registration.
- (iv) Firm should produce ITR for last 3 years.
- * Definition of similar work means: The work executed by firm of replacement/installation of blinds, interior designing and furnishing work. The firms having experience in civil work shall also be considered.

- 17. Evaluation & Award of work: The bids will be evaluated as per the Eligibility criteria given at Clause 15 & 16 above. The bids which are found to be fulfilling the eligibility criteria shall only be considered for opening of Price-Bids. MP-IDSA may seek clarifications in the bids from the bidders during the evaluation process. The work will be awarded to the lowest responsive (L-1), evaluated bidder and Work- order will be issued to the firm. MP-IDSA may like to visit the similar completed works of the successful bidder before considering their bid/ award of work. Substantially responsive financial bids will be checked for any arithmetic errors. Arithmetic errors are to be rectified on the basis of the standard procedure as follows:
 - a) If there is a difference between the amount of rate in figure and in words of an item, and the total amount is worked out, then the rate which corresponds to the amount worked by the bidder shall be taken as correct.
 - b) If the bidder has not worked out the amount of an item, or the same does not correspond with the rates written either in figures or in words, then the rate quoted by him in words shall be taken as correct.
 - c) If the rate quoted by the bidder in figures and in words tallies, but the amount is not worked our correctly, the rate quoted by the contractor shall be taken as correct and not the amount.
 - d) If the selected bidder refuse to execute the work after award of work, his EMD will be forfeited.
- 18. Time of Completion and Extension for delay:

- i) The work shall be completed within 30 days from the date of receipt of work order from MP-IDSA.
- ii) Due to an event, not attributable to the contractor, causing delay, occurs or a variation order is issued, which makes it impossible to complete the work by scheduled completion date, MP-IDSA may consider extending the completion date on the specific request of the contractor.

19. Dispute Resolution.

- (a) Any dispute and or difference arising out of or relating to this contract will be resolved through joint discussion of the authorities' representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to a sole Arbitrator appointed by the Director General, MP-IDSA.
- (b) The award of the sole Arbitrator shall be final and binding on all the parties. The arbitration proceeding's shall be governed by Indian Arbitration and Conciliation Act 1996 as amended from time to time.
- (c) The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of contract, neither party shall be entitled to suspend the work/service to which the dispute relates on account of the arbitration and payment to the contractor shall continue to be made in terms of the contract. Arbitration proceedings will be held at Delhi/New Delhi only.

Additional Conditions

- (A) All the T& P is to be arranged by Contractor and nothing extra shall be paid on this account
- (B) The contractor shall make his own arrangement for making electric connections to equipment like drill machine etc. If any.
- (C) The Contractor shall be bound to follow the restrictions on the movement of labour, at MP-IDSA campus due to security or any other reason(s). No Claim shall be entertained on this account.
- (D) The contractor shall personally responsible for violation of any guidelines and shall have to pay the fine /penalty imposed by appropriate authority. No claim on this account shall be entertained.
- (E) TDS & GST will be deducted as per applicable rules.
- (F) The contractor shall be fully responsible for safe custody of the material even if the materials are under double lock system.
- (G) Quantity can be increased or decreased depending upon the requirements.
- (H) Contractors are advised to Visit the site and condition before quoting. After opening the bids no excuse will be entertained with regards to site conditions, security restrictions, etc.
- (I) Due care must be taken to ensure that existing services are protected and not damaged during the course of the works. In case of any damage to such items during the course of the works, the same shall be got done at the risk and cost of the agency.
- (J) The Contractor is required to comply with all Acts of Government relating to labour, safety, environment and other Rules and Regulations made there under from time to time and to submit at the proper times all particulars and statements required to be furnished to the appropriate Authorities.

Director General, MP-IDSA reserves the right to accept or reject the lowest or any offer or all offers without assigning any reasons thereto.
